



UEFA EURO 2020 FUN ZONE BUDAPEST EVENT POLICY

The present policy of the UEFA EURO 2020 FANS ZONE (Event) organized by the BFK Budapest Development Center Nonprofit Private Limited Company (Organizer) contains the mandatory entry and conduct rules for the Event.

The Visitor entering the area of the Event considers it binding on himself / herself

Venue of the event:	Városligeti Műjégpálya és Csónakázótó 1146 Budapest, Olof Palme sétány 5.
Date of the event:	June 11, 2021 - July 11, 2021
Opening hours of the Event:	On match days: 11:00 to 23:00 Rest days: 11:00 to 22:00

ENTRY TO THE EVENT

1. Admission to the Event is free for everyone.
2. As the event is held in a natural environment, the accessibility of the area - the event venues - is not or only partially solved, so the person with reduced mobility / disabled can enter the area only at his / her own risk and with an escort.
3. Body temperature measurement is mandatory to enter the event area.
In case of body temperature above the limit set by the health authorities (currently 37.8 degrees), the person will be directed to the isolation tent.
4. Rules for entering the Fan Zone area.
 - 4.1. Rules for Hungarian citizens:
 - Under 18 years old visitors:
 - with a Vaccination Certificate, OR
 - can enter with an adult escort owning a Vaccination certificate.
 - Over 18 years old visitors:
 - with a Vaccination Certificate, OR
 - you can enter the event with a wristband valid to the Puskás Arena on a given day (15/06/2021 or 19/06/2021 or 23/06/2021 or 27/06/2021)



4.2. Rules for foreign nationals:

- with a negative PCR test, performed within 72 hours before entry (in Hungarian or English), OR
 - with a proof that You have had COVID-19 within 6 months (in Hungarian or English), OR
 - with a Vaccination Certificate acceptable in Hungary, based on the principle of reciprocity, OR
 - you can enter the event with a wristband valid to the Puskás Arena on a given day (15/06/2021 or 19/06/2021 or 23/06/2021 or 27/06/2021)
5. In case of leaving the Event area, the same rules apply before re-entry as for the first entry.
 6. You can enter the Event area with 1 handbag / backpack not larger than 1 A4 size (29.7x21 cm) per person.
 7. In order to ensure the safe conduct of the Event, you must not enter with drugs, pyrotechnic devices, glassware, umbrellas, objects or devices containing explosive, toxic or flammable substances, as well as firearms, any spraying and cutting equipment, gas spray, metal chains longer than 50 centimeters or other, in the current legislation on devices which are particularly dangerous to public safety – by the 175/2003. (X. 28.) Government Decree.
 8. Drones cannot be brought into the Event area.
 9. Foods and drinks are not allowed to bring in the Event area.
 10. It is forbidden to enter the Event area by vehicle during opening hours.
 11. No animals may be brought into the Event area, exceptions are the assistance dogs, guide dogs and police dogs specified by law..

RULES OF CONDUCT

1. Visitors of the Event must comply with the general norms in accordance with the relevant legal regulations and policies. The Visitor is obliged to refrain from any manifestation, communication or action that may endanger or violate the privacy rights, life, health or physical integrity of others..
 - 1.1. Those who endangers others life, physical integrity, property rights of other persons; or endangers the integrity of their property, and the natural environment – his/her entry can be **denied and removed from the event.**
 - 1.2. He/she commits a riot or behaves otherwise as a basis for a police action - his/her entry can be **denied and removed from the event.**



- 1.3. Incites against members of other social groups or otherwise incites unrest within the public by his aggressive behavior - his/her entry can be **denied and removed from the event.**
- 1.4. In the event of an attempt to enter illegally, a person's entry may be refused.
2. The Visitor acknowledges that the Organizer and the Contracted Partners, Contributors, press officers, other Visitors and other third parties may make audio and video recordings of the Events..
3. Accordingly, by participating in the Events, the Visitor expressly consents to the recording and communication of his / her face, appearance, without being named only with his / her express consent.
4. If the Visitor qualifies as a public figure, he / she may be named without his / her consent.
5. In the above-mentioned displays, its creator acquires unlimited, transferable and exclusive use rights from the Visitor in terms of space, time and mode of use.

The Organizer and the persons authorized by the Organizer have the right to utilize, use (especially to promote the Events), reproduce, publish to the public and distribute the display without restriction, without having to provide the Visitor with any compensation.
6. The Visitor acknowledges that the Organizer records the Event or programs, duplicates the recorded recording and distributes, broadcasts or otherwise transmits it to the public.
7. The Visitor is not entitled to make any claim or claim against the Organizer in connection with the display as described above.
8. It is forbidden to carry out any economic, commercial or advertising activity in the Event area, including the area before the Event entrance.
9. It is forbidden to serve alcoholic beverages to persons under the age of eighteen in catering establishments.
10. For visitors, any demonstration at the Event that is not related to the events organized by the Organizer, regardless of the number of participants, is prohibited!
11. Contributors with appropriate professional qualifications and licenses in the field of the Event will ensure the enforcement of the rules of conduct and safety.



OTHER PROVISIONS

1. The Organizer is solely responsible for any intentional breach of contract attributable to him or her, which is detrimental to human life, physical integrity or health, and expressly excludes the Visitor's liability for all other damages in addition to his / her rights under the law.
2. The Event may be held by the Organizer in case of bad weather. The Event will not be held if the authorities are obliged to suspend or close it due to force majeure.
3. You can contact the staff at the information points at the venues indicated on the map with comments, complaints about the hospitality, or the organizers or anything else. The found objects can be handed over there too and you can also inquire about the lost objects there.
4. Smoking is only allowed in the designated areas.
5. The Event is cash-free, and Visitors can pay for their consumption with a UEFA EURO 2020™ card or a contactless/Pay pal bank cards issued by specified banks. The UEFA EURO 2020™ card can be picked up at designated recharging points. The balance of the card can be redeemed at the venue of the event, during the opening hours of the event, at the marked point of the venue.

The Organizer reserves the right to make changes.
